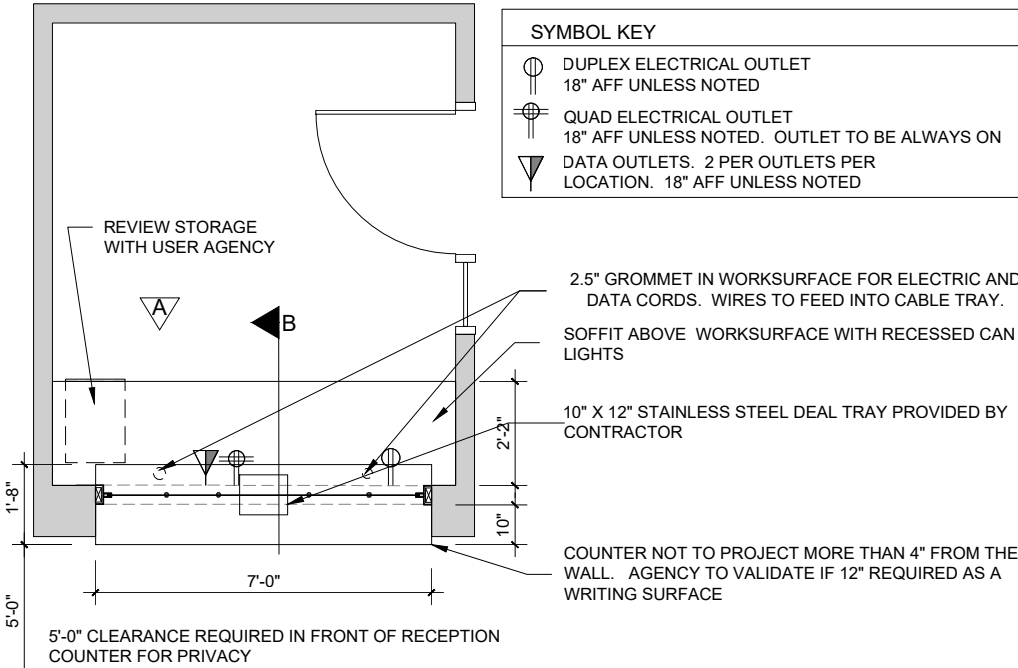

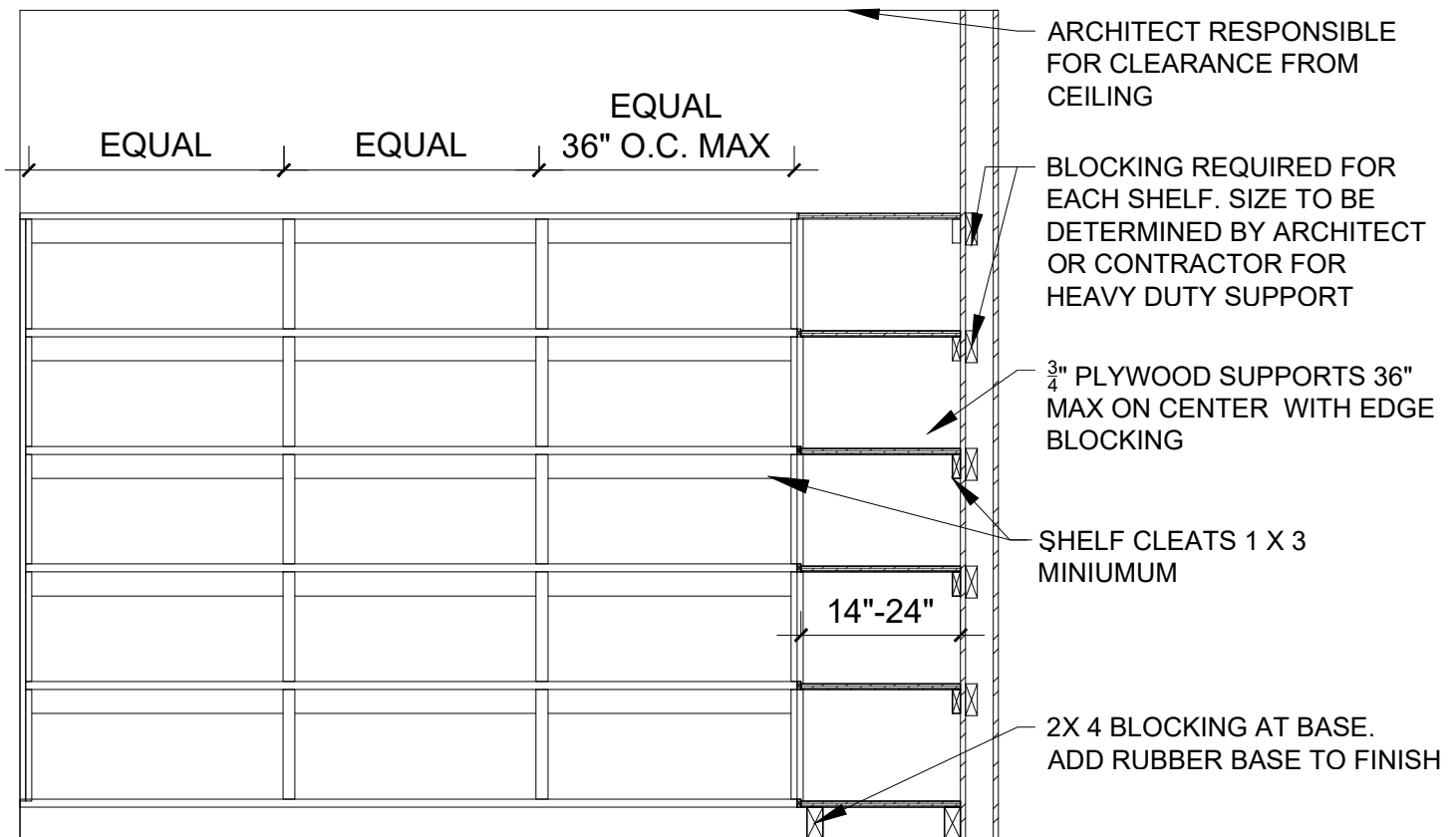

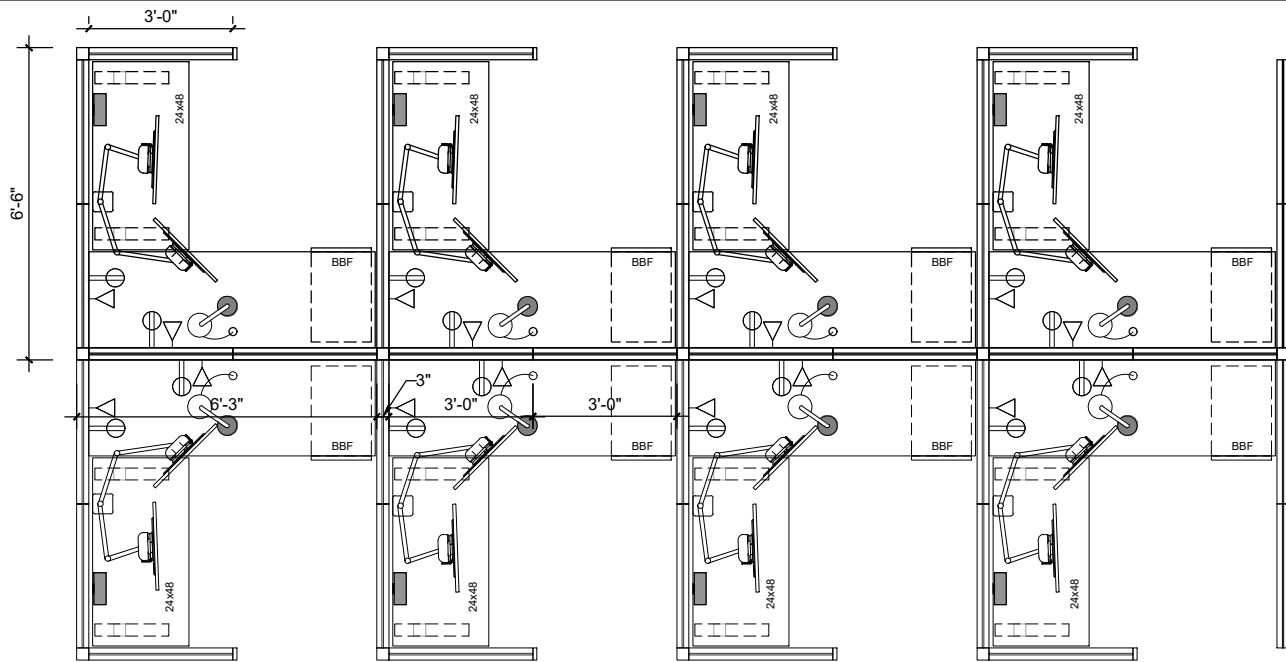

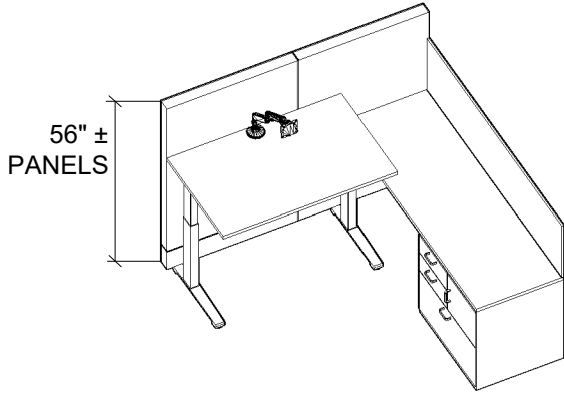

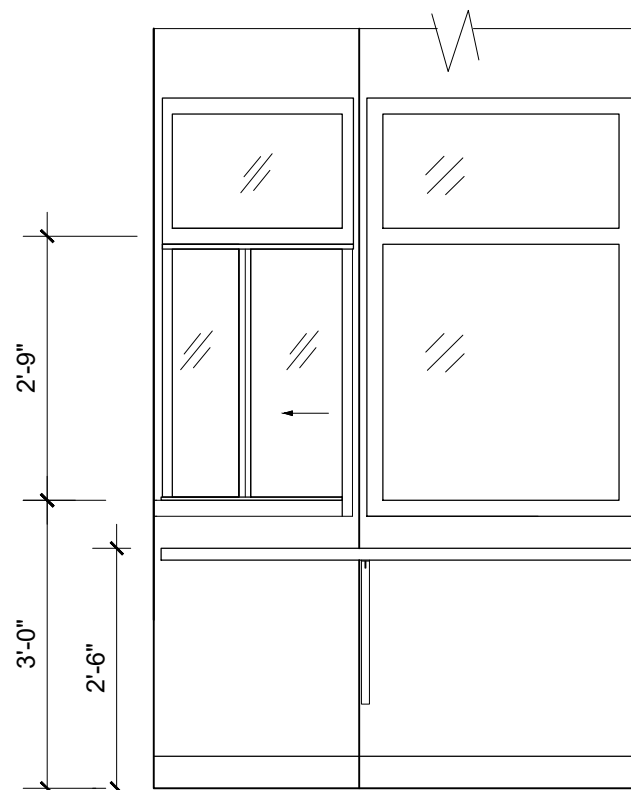


PLAN FAMILY RM 200 SQFT & 150 WITH SOCIAL WORK ALCOVES

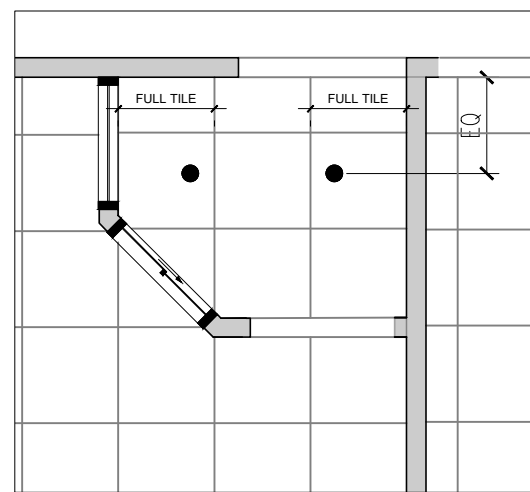


WALL SECTION SOCIAL WORK ALCOVE COUNTER SCALE 1" = 1'-0"

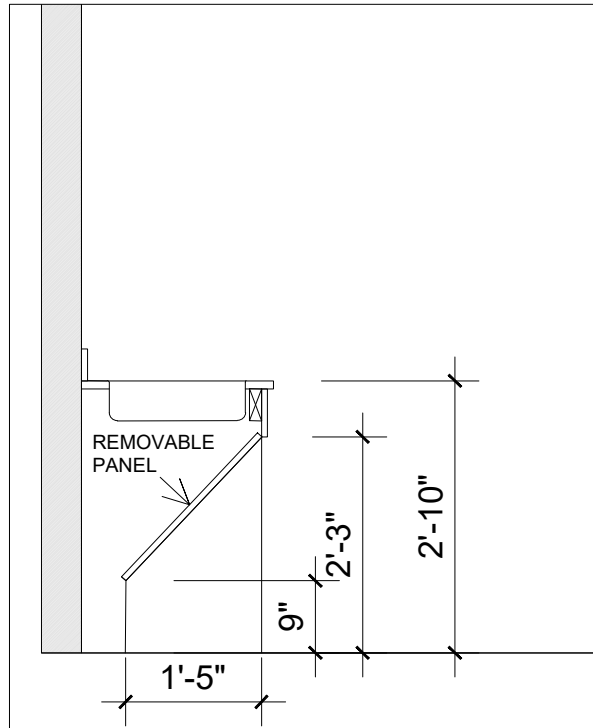



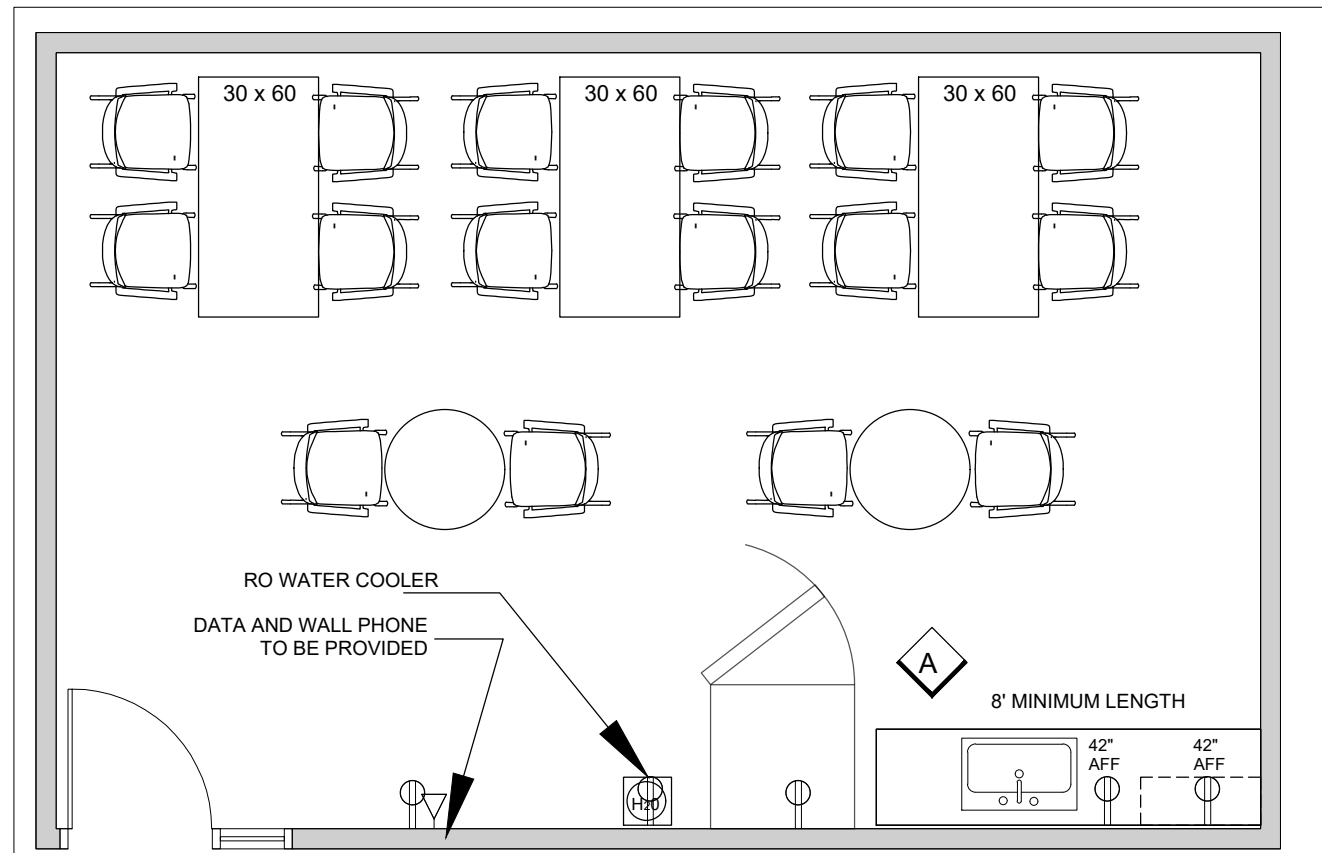

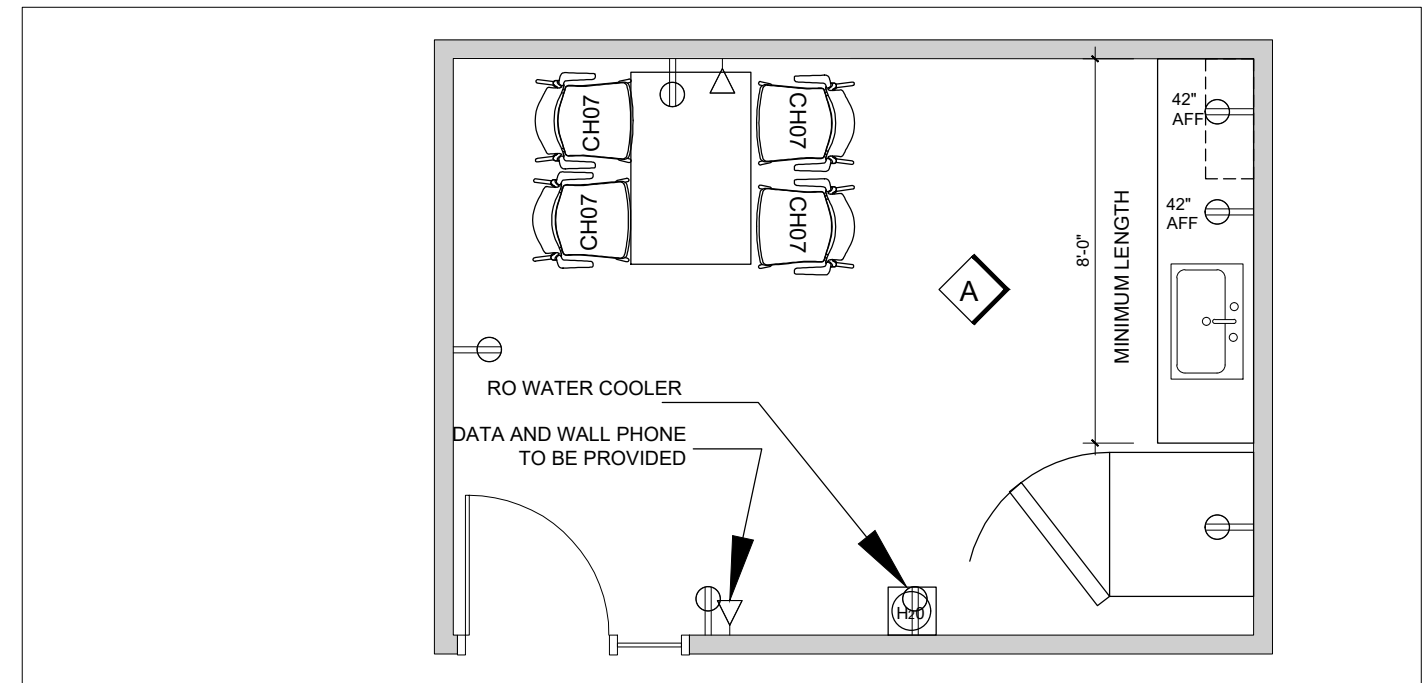

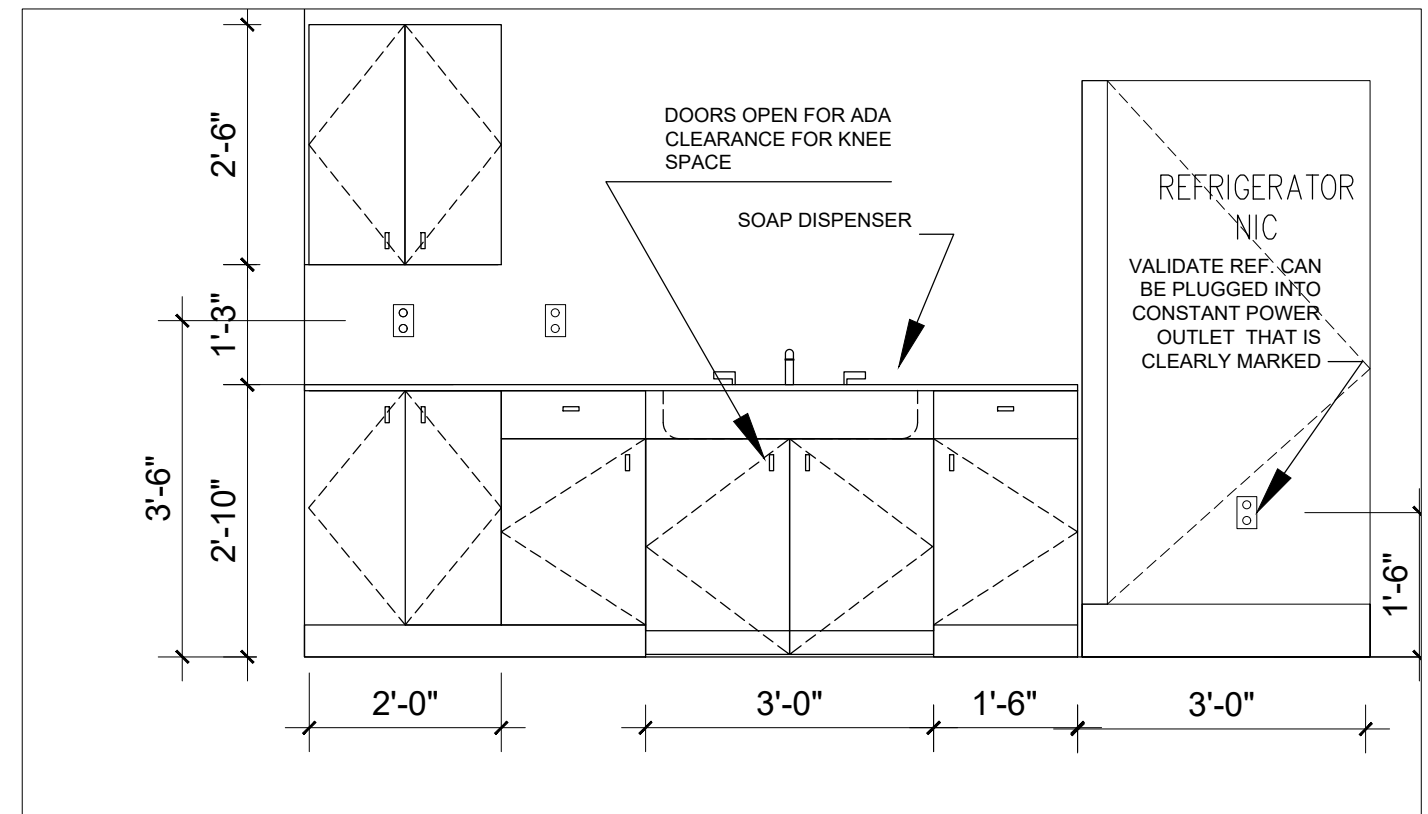
TYPICAL PLAN 400 SQ FT STAFF SUPPORT SPACE
